CITY COUNCIL MEETING
September 11, 2007**

Invocation for the Plainfield City Council meeting was given by Pastor Shawn Geer of the First Baptist Church and Pledge of Allegiance was led by Mayor Tim Neil.

The Plainfield City Council met in regular monthly session September 11, 2007 at the Plainfield Public Library at 7:30 p.m. with Mayor Tim Neil presiding and council members Clyde Balvanz, Mike Hyde and Larry Miller present. Kyle Adams and Tom Geise were absent.

The following department heads were in attendance: Maintenance Supervisor Steve Janssen. Fire Chief Tom Poppe entered the meeting at 8:00 p.m.
