CITY COUNCIL MEETING
April 8, 2008**

The Plainfield City Council met in regular monthly session April 8, 2008 at the Plainfield Public Library at 7:00 p.m. with Mayor Pro Tem Tom Geise presiding and council members Kyle Adams, Larry Poppe and Kathy Remley present. Mayor Tim Neil and Council Member Clyde Balvanz were absent.
