The Plainfield City Council met in regular monthly session April 14, 2009 at the Plainfield Public Library at 7:00 p.m. with Mayor Pro Tem Tom Geise presiding and council members Tom Geise, Larry Poppe and Kathy Remley present. Council Members Kyle Adams and Clyde Balvanz were absent.
