Invocation for the Plainfield City Council meeting was given by Tom Geise and Pledge of Allegiance was led by Matthew Bottorff and Gabe Peterson of Boy Scout Pack 57.

The Plainfield City Council met in regular monthly session November 11, 2008 at the Plainfield Public Library at 7:00 p.m. with Mayor Tim Neil presiding and council members Kyle Adams, Clyde Balvanz, Tom Geise, Larry Poppe and Kathy Remley present.

The following department heads were in attendance: City Clerk Brittney Lentz, Fire Chief Tom Poppe and Maintenance Supervisor Steve Janssen.

Motion Geise, Adams to approve the agenda after deleting item number 8, a building permit for Stacey Nelson. Ayes: Adams, Balvanz, Geise, Poppe and Remley. Nays: None. Carried.

Motion Poppe, Balvanz to approve the consent agenda; which included the minutes of October 14, 2008, bills for the month of November 2008 and the Clerk's Reports. Ayes: Adams, Balvanz, Geise, Poppe and Remley. Nays: None. Carried.
