September 8, 2009**

The Plainfield City Council met in regular monthly session September 8, 2009 at the Plainfield Public Library at 7:00 p.m. with Mayor Tim Neil presiding and council members Kyle Adams, Clyde Balvanz, Tom Geise, Larry Poppe and Kathy Remley present.

The following department heads were in attendance: Bremer County Sheriff's Deputy Robert Whitney, City Clerk Brittney Lentz, Fire Chief Tom Poppe and Maintenance Supervisor Steve Janssen.
