The Plainfield City Council met in regular monthly session March 12, 2013 at the Plainfield Public Library at 7:00 p.m. with Mayor Tom Geise presiding and Council Members Kyle Adams, Clyde Balvanz, Shawn Geer and Kathy Remley present. Council Member Doug Berger was absent.
