

**CITY OF PLAINFIELD  
CITY COUNCIL MEETING  
November 8, 2011**

Invocation for the Plainfield City Council meeting was given by Mayor Geise and Pledge of Allegiance was also led by Mayor Geise.

The Plainfield City Council met in regular monthly session November 8, 2011 at the Plainfield Public Library at 7:00 p.m. with Mayor Tom Geise presiding and council members Doug Berger, Larry Poppe and Kathy Remley present. Council Members Clyde Balvanz and Shawn Geer were absent.

The following department heads were in attendance: City Clerk Brittney Lentz, Fire Chief Tom Poppe and Maintenance Supervisor Steve Janssen.

Motion Poppe, seconded by Berger to approve the agenda. Ayes: Berger, Poppe and Remley. Nays: None. Motion Carried.

Motion Berger, seconded by Remley to approve the consent agenda; which included the minutes of October 11, 2011, bills for the month of November 2011 and the Clerk's Reports. Ayes: Berger, Poppe and Remley. Nays: None. Motion Carried.

Motion Poppe, seconded by Berger to approve a building permit for 815 Main Street. Ayes: Berger, Poppe and Remley. Nays: None. Motion Carried.

Fire Chief Poppe reported that the Fire Department purchased 4 Life Vests to be used during water rescues. They will also be purchasing a safety light for the back of the rescue van and new collapsible cones with proceeds from their recent fundraiser.

Motion Poppe, seconded by Remley to sign a 3 year Pump Maintenance Service agreement with Electric Pump, for service to the pumps at the lift station, water tower and sewer lagoon, for the amount of \$1,363.78. Ayes: Berger, Poppe and Remley. Nays: None. Motion Carried.

Motion Remley, seconded by Berger to accept the monthly department reports. Ayes: Berger, Poppe and Remley. Nays: None. Motion Carried.

City Clerk Lentz read a letter about the Title Opinion for the City Hall/Maintenance Property, from City Attorney Boveia. Mayor Geise will be discussing the results of the Title Opinion with D and J Enterprises. After everything is settled the property closing will be scheduled.

Mayor Geise appointed Council Members Poppe and Remley, City Clerk Lentz and Maintenance Supervisor Janssen to the City Hall/Maintenance Building Committee.

Motion Remley, seconded by Berger to adopt Resolution No. 11-12: A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PLAINFIELD, IOWA, APPROVING THE 2010/2011 FISCAL YEAR CITY FINANCIAL REPORT. Roll Call Vote- Ayes: Berger, Poppe and Remley. Nays: None. Motion Carried.
