

**CITY OF PLAINFIELD
CITY COUNCIL MEETING
November 13, 2012**

Invocation for the Plainfield City Council meeting was given by Pastor Shawn Geer and Pledge of Allegiance was led by Tom Geise.

The Plainfield City Council met in regular monthly session November 13, 2012 at the Plainfield Public Library at 7:00 p.m. with Mayor Tom Geise presiding and Council Members Clyde Balvanz, Doug Berger, Shawn Geer and Kathy Remley present. Council Member Kyle Adams entered meeting at 7:06pm.

The following department heads were in attendance: City Clerk Brittney Lentz, Fire Chief Tom Poppe, Librarian Clarence Bergmann and Maintenance Superintendent Andy Luck.

Motion Berger, seconded by Remley to approve the agenda. Ayes: Balvanz, Berger, Geer and Remley. Nays: None. Motion Carried.

Mayor Geise read a letter from Mr. Scott Weinberg concerning the blocking of water on his property. Mayor Geise will discuss the issue with the IA DOT, as the City Council does not have the authority to remove the blockage.
