

**CITY OF PLAINFIELD  
CITY COUNCIL MEETING  
September 11, 2012**

Invocation for the Plainfield City Council meeting was given by Pastor Shawn Geer and Pledge of Allegiance was led by Tom Geise.

The Plainfield City Council met in regular monthly session September 11, 2012 at the Plainfield Public Library at 7:00 p.m. with Mayor Tom Geise presiding and Council Members Kyle Adams, Doug Berger and Shawn Geer present. Council Members Clyde Balvanz and Kathy Remley were absent.

The following department heads were in attendance: City Clerk Brittney Lentz, Fire Chief Tom Poppe and Maintenance Superintendent Andy Luck; along with 1 visitor.

Motion Adams, seconded by Berger to approve the agenda. Ayes: Adams, Berger and Geer. Nays: None. Motion Carried.

Motion Adams, seconded by Geer to approve the consent agenda; which included the minutes of August 14, 2012, bills for the month of September 2012 and the Clerk's Reports. Ayes: Adams, Berger and Geer. Nays: None. Motion Carried.

Mayor Geise read Ordinance No. 23: AN ORDINANCE AMENDING ORDINANCE NO. 135.14, BY ADDING AN ADDITIONAL SECTION 135.4(6), AS IT RELATES TO PLACEMENT OF RURAL MAILBOXES NEAR AN INTERSECTION. No comments were received.

Motion Geer, seconded by Berger to approve the second reading of Ordinance No. 23: AN ORDINANCE AMENDING ORDINANCE NO. 135.14, BY ADDING AN ADDITIONAL SECTION 135.4(6), AS IT RELATES TO PLACEMENT OF RURAL MAILBOXES NEAR AN INTERSECTION. Kirk Hummel of 1<sup>st</sup> National Bank was present to discuss setting up a co-op or corporation between the Bank and the City of Plainfield to build the new city hall/maintenance building. Motion Geer, seconded by Adams to accept the monthly department reports. Ayes: Adams, Berger and Geer. Nays: None. Motion Carried.

Motion Geer, seconded by Berger to set Halloween Trick-or-Treating for Wednesday, October 31<sup>st</sup> from 5:30-7:30pm. Ayes: Adams, Berger and Geer. Nays: None. Motion Carried.

Motion Adams, seconded by Berger to approve Resolution No. 12-09: A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PLAINFIELD, IOWA, APPROVING THE 2012 FISCAL YEAR STREET FINANCIAL REPORT. Roll call vote- Ayes: Adams, Berger and Geer. Nays: None. Motion Carried.
