The Plainfield City Council met in a regular monthly session February 14, 2007 at the Plainfield Public Library at 7:00 p.m. with Mayor Tim Neil presiding and council members Kyle Adams, Clyde Balvanz, Tom Geise, Mike Hyde and Larry Miller present.

The following department heads were in attendance: Maintenance Supervisor Steve Janssen, Fire Chief Tom Poppe and First Responder Gary Carpenter.
